- Five Star Tennis Center may, from time to time, increase or otherwise amend all dues, initiation or other fees.

# MEMBERSHIP POLICY

- All memberships with the exception of the Adult month to month and college require a 12-month initial contract agreement to be signed. Annual prepaid memberships with the exception of the Jr. Development will convert automatically to a monthly membership until canceled with a 30 day written notice.
- All annual monthly memberships will continue after the first 12 months on a monthly basis until canceled with a 30 day written notice.
- Early cancellations of memberships will be assessed a cancellation fee of 50% of the remaining dues. Prepaid membership contracts may not be canceled early.
- All monthly memberships require an initiation fee. If a membership is canceled for any reason; a new initiation fee will be required to re-join the club.
